This qualification reflects the role of support workers who complete specialised tasks and functions in aged services; either in residential, home or community based environments. Workers will take responsibility for their own outputs within defined organisation guidelines and maintain quality service delivery through the development, facilitation and review of individualised service planning and delivery.



This qualification is typically delivered over a minimum duration of 13 months, including 120 hours of work placement in an aged care facility.



Upon completion of this qualification, students are eligible to apply for roles such as:

- Support Worker
- Aged Care Worker
- Home & Community Care Worker
- Respite Worker

## IMPORTANT INFORMATION

### DURATION

This qualification is typically delivered over a minimum duration of 13 months, including 120 hours of work placement in an aged care facility.

### DELIVERY

The training is conducted by a qualified, industry current, trainer and assessor to ensure the learning is relevant and up to date. This training will take place in a classroom environment using face-to-face training methods at one of our study locations. Intakes are scheduled throughout the year.

### ENTRY REQUIREMENTS

There are no formal entry requirements for this qualification, although applicants will need to undertake an LLN assessment. Students are required to complete a Practical Placement which requires a police check and NDIS screening.

### FURTHER STUDY OPTIONS

Upon completion, students could go further with their study with our CHC43115 - Certificate IV in Disability.
